

# Temporary Local Rules Noordwijkse Golfclub

Effective as of June 24, 2024



In addition to the local rules published on the scorecard and the notice board, the following temporary local rules are in effect.

## FLOODING – DROP ZONES

- Bunkers from which cannot be played due to flooding are indicated as GUR; these bunkers are part of the general area from which free relief is available.

All other bunkers whether they contain temporary water or not, are still bunkers under the rules.

- Temporary water on the course in the general area is GUR by definition.

In some situations, in addition to the options provided under Rule 16.1, a drop zone is established. The drop zone is the area within one club length from the “DZ” sign. The ball must be dropped and come to rest within this one clublength from the nearest “DZ” sign.

## ANT HILLS

Ant hills on the course are, at the player's option, loose impediments that may be removed under Rule 15.1 or ground under repair from which relief is allowed under Rule 16.1.

## No play zone – areas with sheep

The areas surrounded by electric fencing to contain the grazing sheep (with or without sheep) are abnormal course areas defined as no play zones. The boundary of these areas is one club length from the fence. When there is interference from these areas, free relief must be taken according to Rule 16.1f.

It is forbidden to enter the fenced areas.

## No play zone for the recovering dune area

### ENTRY INTO THE MARKED AREA LEFT OF HOLE 7 AND LEFT OF HOLE 11 IS FORBIDDEN

This area needs to recover after the work done. Therefore, it remains forbidden to enter this area. This area is defined by green topped stakes. Balls in this area must be left there.

## No play zone for the grass nursery

### ENTRY INTO THE FENCED OFF AREA LEFT OF HOLE 14 IS FORBIDDEN

The grass nursery short left of the path crossing the fairway has been fenced off. It is forbidden to enter this area. Balls in this area must be left there.

## ABNORMAL COURSE CONDITIONS AS A NO PLAY ZONE

“The aforementioned areas are no play zones that are to be treated as an abnormal course condition. Free relief MUST be taken from interference by the no play zone under Rule 16.1f.”

## DROP ZONE

On hole 11 and on hole 14, there are drop zones as an extra option to take relief in addition to the options provided under Rule 16.1f. On hole 11 and on hole 14, the player may take relief from such an area by dropping a ball in the drop zone. When dropping a ball in the drop zone, the ball MUST land and come to rest in the drop zone.

**The penalties mentioned below for breaching a local rule and the code of conduct will be applied separately and cumulatively.**

**Penalty for Playing Ball from a Wrong Place in Breach of Local Rule: *General Penalty Under Rule 14.7a.***

## CODE OF CONDUCT

Penalty for entry into a no-play-zone into which entry is forbidden:

- **General penalty in competitions;**
- **The board will decide on possible disciplinary measures.**
